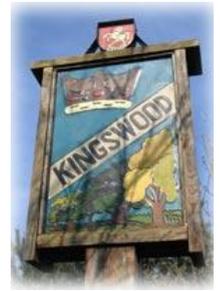

2	Welcome by the Parish Council Chairman, Tina Clark
3	Minutes of the Annual Parish Meeting held on 16th May 2016 Were agreed to be a true record of the meeting and was signed by Clr Darling at the Parish Council meeting on the 20 th June 2016.
4	Chairman's Annual Report (2016/17) Clr Clark (Chairman), read out the annual report which is retained on file and also available on the Parish Council website and in the Annual Reports document at the Post Office.
5	Responsible Finance Officer's Report (2016/17) The Finance Report was read by the Clerk/RFO and is retained on file, but is also available on the Parish Council Website and in the Annual Report document at the Post Office
6	Kent County Council Report 2016/17 Clr Shellina Prendergast welcomed the opportunity to thank those residents who voted for her in the KCC elections of only 9 days ago. She therefore had nothing to report from the previous year, but is currently reviewing the KCC Annual Report. She looks forward to working closely with the parish in the future.
7	Maidstone Borough Council Report (2016/17) Clr Gill Fort reported:- Signed _____

- Local Plan – designed to manage the development of homes, jobs and the environment. The Interim report from the public examination was published before Christmas and MBC are currently reviewing modifications resulting from the report. The final hearing is due soon.
- MBC held a consultation “Your service, You decide” to help determine the budget for 2017/18, the public priorities were found to be household waste, street cleaning and street services. Town Centre improvements were also considered important. Heritage, leisure and tourism were considered the least essential of the services.
- Commercial development at J8 of the M20 was rejected by the MBC Planning Committee but the applicants have appealed this decision. MBC have confirmed their intention to challenge the appeal.
- Relief Road for Leeds and Langley, despite the examiner concluding this was not an essential provision within the Local Plan MBC and KCC Councillors continue to press for this to be included. Proposed routes for a relief road will be going out to consultation in the future.

8 Reports from External Organisations

Reports have been published in the Annual Parish Meeting booklet. There were no additional reports on the evening.

9 Q & A session with members of the Public

9.1 Neighbourhood Watch Co-ordinator details. The Clerk explained that unfortunately there was a vacancy for a NHW co-ordinator following the sudden death of Mike Evans.

9.2 What is the Precept – The Clerk explained the precept is monies received via the borough council to pay for the management of the parish through the parish council. This is an addition to the Council Tax already paid to the borough.

9.3 Why is the end of year carry over figure so high – The Clerk explained that monies were held over for the installation of additional play equipment at the sports field; also that it had been hoped following a successful outcome to the Neighbourhood Plan the monies would kick start the process of establishing the initial requirements. In addition it is hoped that the Parish Council will be able to help with the sustainability of the Kingswood Pre-school, possibly by helping with an extension to the Village Hall, which would include a Parish Council Office.
